INTRODUCTION

The main idea for creating the Businessmen catalog stemmed from the need of the City Administration to bring businessmen from Gradiška closer to clients from abroad, and thus contribute to the increase in export, which is the key driver of each economy. ABOUT GRADIŠKA

The area of the city of Gradiška is situated in the upper reaches of the Sava River in the western part of the Republic of Srpska and covers its northern central part. It consists of lowland part of the Lijevče field, hills of the northern part of Potkozarje and smaller mountain part of Kozara and Prosara, with the area of 762 km². The city of Gradiška has a population of about 49,196 inhabitants, with about 13,691 inhabitants living in the urban part of the City.

One of the major international border crossings for passenger and freight traffic in the Republic of Srpska / Bosnia and Herzegovina is situated in Gradiška. Direct access to the Sava River, the natural openness by the "Sava corridor" to the east and west, and openness through mountain hinterland to the south towards the Adriatic, give Gradiška very favorable traffic-geographical position. Such inter-regional significance gives an important transit role to this area.

Favorable climate, mild continental conditions and geographical position, large forest richness of the mountains Kozara and Prosara, fertile Lijevče field and parts of Posavina, suitable hilly arable land, the potential of the Sava River and other benefits, have affected the development of numerous economic areas.

The economy of the City of Gradiška began to develop in the second half of the 19th century, during the Austro-Hungarian Monarchy, firstly in the area of agriculture and wood industry, and then in the other economic sectors. The highest economic growth and development were achieved after the WW II, and until the 90s of the last century. However, due to the war conflict, the physical volume of industrial production abruptly decreased, until 1995, but after that period and process of privatization of state-owned companies, construction of new economic structure has succeeded.

Successful economic development has been achieved in the previous period, the economic situation is constantly improving by construction of new economic and infrastructural facilities, by increase of production and export to foreign markets, and by employing new labor force. Economic development has been successfully followed by development of utility and service activities. There are 504 companies and 1,055 economic entities that currently operate on the area of the city. Most of the activities of economic sector are focused on the following economic activities:






- Wood-processing and furniture manufacturing,
- Metal-processing industry,
- Textile industry,
- Production and processing of fruit and vegetables,
- Manufacturing of plastics,
- Trade.

In the last three years, on the territory of the city of Gradiška, for the purpose of domestic and foreign investments, there has been established Greenfield location, the Agroindustrial zone Nova Topola. The Zone covers the area of 144 ha, it is situated next to the highway road M-16 Gradiška-Banja Luka. It leans on the existing regional road M-14.1 Derвента-Srbac-Nova Topola-Ča-trnja-Kozarska Dubica, with connection to the highway E661 Banja Luka-Gradiška.
